



# Request for Proposal from Self-Determination Local Advisory Committee for RCEB

**Issued: August 19, 2025** 

Deadline for submission: October 15, 2025

**Project: Moving Forward in Self-Determination** 

## **Background:**

Self-Determination Local Advisory Committees (SDLAC's) were established by law to provide oversight of the Self-Determination Program (SDP) and make recommendations for improvement to each local regional center and the Department of Developmental Services. Funds are granted annually by the Department of Developmental Services (DDS) to the SDLAC's and Regional Centers to support the implementation of the SDP. The SDLAC for Regional Center of the East Bay (RCEB) has prioritized the needs in the local area for the use of the funds, and is seeking proposals from interested parties to carry out one or more of the projects which the committee wishes to fund.

#### **Timeline for Moving Forward in Self-Determination:**

- Applications must be submitted by October 15, 2025
- Applications will be reviewed in late October 2025
- Applicant interviews will be held in early November 2025 with selection notification being made by the end of November.
- Projects will begin immediately, and must be completed by mid-March 2025.

Applicants with disabilities and/or diverse backgrounds are encouraged to apply.

Applicants outside of the Bay Area are also encouraged to apply.

**Total Available: \$10,000** 

**General Description:** This project will help those currently in Self-Determination, both service recipients and family members, to feel more confident about maintaining their program by providing strategies to address specific challenges, connecting with others in SDP, and increasing confidence in the program.

#### **Desired outcomes:**

- For those in their first year of SDP to feel more confident about maintaining their program
- To learn strategies to address specific challenges they may experience, such as hiring and managing staff, finding specific resources, keeping abreast of changing/updated DDS guidance or RCEB procedures
- Connect with others in SDP for support and resource sharing
- Increase confidence in the program and be more able and motivated to promote it in their community, assist others informally, and be a 'cheerleader' for the program

## Suggested structure:

- Offered in both English and Spanish (ideally one contractor that can do both)
- Presentations/meetings to take place between the first of January and early March
- Provide a unique topic for each of three presentations (3 in English and 3 in Spanish, for a total of 6)
- Attendees will have the option to attend all, or just select based on topic
- 90 minutes per meeting, including up to 45 minutes on the presentation, the remainder for Q & A/discussion/community building
- Include opportunities for networking and peer support among attendees during the meetings and outside of the meetings
- Possibly distribute information or resources on the scheduled topic prior to the meeting

## **Ideal contractor** has experience working with:

- RCEB specifically, either as an Independent Facilitator, service provider or service recipient/family member,
- a variety of ages of clients,
- a range of support needs,
- a variety of FMS models, including hiring staff directly
- and, for proposals including Spanish presentations, experience working with Spanish speaking clients and families.
